### Introduction

2012 has been a momentous year for the Bournemouth, Christchurch and Poole Trades Union Council. After years of regular meetings, but little in the way of activity, it was decided to redevelop the organisation with a focus and emphasis on campaigning. Key to this is the ongoing need to recruit more and more branches into the organisation, ensure decent attendance at meetings where local concerns can be discussed and to re-establish the trades council as the hub of union activity in the area. It is crucial that BCPTUC is seen as relevant to the concerns of local trade unionists – and this year has certainly helped breathe new life into the organisation. By working together we can ensure that 2013 is even better.

### A year of development

At the AGM in January 2012, the following motion from the Bournemouth and Dorset NUJ branch was adopted:

"In light of the current political and industrial climate, there is an urgent need for the Trades Council to develop its natural role as a co-ordinator of local activities, campaigns and events - in order to assist both individual unions and the wider community to promote their shared values and policies as effectively as possible. The Trades Council should therefore enhance its structure and organisational techniques with the following programme of development:

- Commission the design of a suitable, eye-catching logo
- Set up a website to act as a hub of local union and community information
- Embark on an intense campaign of recruitment and affiliation from local trade union branches
- Adapt the current organisational approach to encourage fewer meetings and more activity-based events. For example, business meetings could be replaced by a series of public meetings and street stall activities, which raise the case for trade unionism and its wider aspirations
- Seek to promote trade union principles in local schools as part of the Citizenship curriculum
- Adopt the annual trades council programme of work where appropriate as the minimum basis for practical work throughout the year

In addition, this AGM calls on the incoming officers to use this programme as the basis for securing a development grant from the South West TUC."

Over the next twelve months, the trades council worked through the terms of the motion, agreeing changes to practices along the way. Specifically, the following work was undertaken:

1. A trades council logo was designed and turned into a lapel badge
2. A trades council website was set up (with thanks to Kevin Smith) and can be seen at [www.bcptuc.org](http://www.bcptuc.org)
3. The trades council has secured more branch affiliation this year than in 2011 (see section on Affiliations for details)
4. It was agreed to hold four business meetings every year (one of which would also be the AGM) with the flexibility for additional Campaign meetings to be called on

an as and when basis. In addition the constitution, standing orders and Campaign Fund rules were also amended in line with this new approach

5. The trades council has adopted those parts of the national work programme that it is able to undertake locally
6. Grants towards this development work were received from both the South West TUC and the national TUC fund
7. A formal re-launch of the trades council took place in May 2012 (see section on Events for details).

## Events

Throughout the year the trades council has either organised or supported a number of local events/activities:

**Workers' Memorial Day** – On 28 April 2012, the trades council laid a wreath at the war memorial in Poole Park to commemorate all those who had died at work. The event received coverage on the local TV news.

## **The year ahead**

### **• Living Wage Campaign**

Over the coming year, the trades council has agreed to take part in the South West TUC's project on the Living Wage. One in five workers in the South West - 482,446 people - earns less than the living wage and the South West TUC is pressing employers to agree to the new Living Wage rate of £7.45 an hour. The living wage is a voluntary rate of pay designed to help low-paid workers to afford a basic standard of living. The South West TUC has calculated that in Dorset, Bournemouth and Poole around 78,000 workers would benefit from the introduction of a Living Wage. The aim will be to encourage local authorities across the region to pay their staff the Living Wage, as well as pushing the Local Economic Partnerships (LEPs) to adopt it as part of their economic strategy and encouraging private sector employers to recognise the benefits of paying it to their staff.

### **• Regional Pay Campaign**

The south west is at the forefront of attempts by 20 NHS Trusts to introduce regional terms and conditions – which could lead to staff having to work longer hours and lose annual leave without any improvements in pay. The trades council recognises that this campaign goes to the heart of what unions are all about – defending

- **Anti-Cuts Campaign**

Back in November 2010 the trades council called a public meeting which led to the creation of the Bournemouth and Poole Anti Cuts Coalition (BPACC). Together the two groups have campaigned against the national and local governments' austerity measures and will continue to do so throughout 2013.
